NOTIFICATION ON EXTENSION OF THE DEADLINES IN THE PROCEDURE

FOR THE GRANTING OF A CONCESSION FOR THE FINANCING, DEVELOPMENT THROUGH THE CONSTRUCTION AND RECONSTRUCTION, MAINTENANCE AND MANAGEMENT OF THE INFRASTRUCTURE OF AD AERODROM NIKOLA TESLA BEOGRAD AND THE PERFORMANCE OF THE ACTIVITY OF AIRPORT OPERATOR

IN ACCORDANCE WITH THE PUBLIC INVITATION PUBLISHED IN THE OFFICIAL GAZZETTE NO. 9/2017 DATED 10 FEBRUARY 2017

2. SUBJECT MATTER OF THE CONCESSION

The subject matter of the concession is the financing, development through the construction and reconstruction, maintenance and management of the infrastructure of ANT and the performance of the activity of airport operator at the Belgrade Nikola Tesla Airport.

3. TYPE OF PROCEDURE

The procedure for granting of a concession is implemented in accordance with Article 20 Paragraph 3 in relation with Article 10 Paragraph 1 of the Law on Public Private Partnership and Concession ("Official Gazette of the Republic of Serbia", no. 88/2011, 15/2016 and 104/2016) (hereinafter referred to as the "**PPP Law**"), as well as Article 41a of the PPP Law and the the Decree on the Manner of Concession Granting in Phases ("Official Gazette of the Republic of Serbia", no. 1/2017).

4. DATE OF PUBLISHING OF THE PUBLIC INVITATION

The Public invitation dated 10 February was published in the Official Gazette of the Republic of Serbia, no. 9/2017, on 10 February 2017, as well as on the webpage of ANT and on the official portal of the Public Procurement Office of the Republic of Serbia on 10 February 2017, in daily newspaper Politika on 13 February 2017 and on the webpage of the Tenders Electronic Daily on 14 February 2017.

5. DATE OF PUBLISHING OF THE NOTIFICATION ON EXTENSION OF THE DEADLINES IN THE PROCEDURE

This Notification on Extension of the Deadlines in the Procedure was published on 9 May 2017 in the Official Gazette of the Republic of Serbia no. 44/2017.

6. REASONS FOR THE EXTENSION OF THE DEADLINES

Upon request of majority of Qualified participants who want to utilise their right, up to expiry of deadline for submission of non-binding bids in Phase I, to form consortiums (group of bidders) with third parties (hereinafter: Adjoined member of consortium), which is in accordance with international practice relating to concessions for airports and having in mind a significant number of questions regarding the possibility of forming of consortiums and adjoining consortiums, in reference to which the Public body posted on 28th April 2017 answer, hence giving instructions to the Qualified bidders, the Public body has decided to extend the deadline for submission of non-binding bids in Phase I, as to allow the Qualified bidders and Adjoined members of the consortium in accordance with principle of PPP Law of equal and just treatment and the principle of free market competition as to allow all Qualified participants and Adjoined members of the consortium sufficient time for preparation of all required documentation in line with Public Invitation, Instructions for bidders for Phase 1 and Qualified participants Questions and Answers necessary for the preparation of the non-binding bids which will be subject of scoring in line with chapter 8 of Instructions to bidders for Phase 1.

In accordance with the stated above the deadlines for Phase 2. are extended although the duration of the Phase 2 remains unchanged.

7. THE NEW DEADLINES

The new deadline for submission of non binding bids is 30th May 2017.

The deadline for making the decision as regards to the bidders who have qualified for participation in Phase 2 remains 10 (ten) calendar days from the date of expiry of deadline for submission of non-binding bids

The deadline for submission of binding offers remains in duration unchanged and is (75) seventyfive days from the date of announcment of bidders which have qualified for Phase 2. on the web site of ANT and Public procurement portal.

The duration of all other deadlines for the actions of the Public body remains unchanged.

8. INFORMATION ON OTHER ELEMENTS (DEADLINES) OF THE PUBLIC INVITATION

Other elements of the Public invitation dated 10 February, remain unchanged.
